Insurance Qualifications

Life & Annuity and Health Insurance

The two-day Fast-Start pre-licensure course occurs each week Monday – Tuesday. The Guided Review option includes additional days of class for focused review. About 8 hours of pre-study and 12-16 hours of post-study will be required. You should plan to pass the state exam within the week following class.

Life and Annuity Insurance

The Life and Annuity only insurance pre-licensure course occurs each Monday in **Richmond** and each Tuesday in **Roanoke & Manassas**.

Health Insurance

The Health Insurance only pre-licensure course occurs each Tuesday in **Richmond** and each Wednesday in **Roanoke & Manassas**.



Personal Lines & Property and Casualty Insurance

The two-day Fast-Start pre-licensure course occurs each week. The Guided Review option includes two additional days of class for focused review. About 8 hours of pre-study and 16 to 24 hours of post-study will be required. You should plan to pass the state exam within the week following class. Check the website for class dates and times.

FINRA Qualifications

Series 6 Representative

The two-day Fast-Start pre-licensure class occurs weekly. To pass the 135-minute, 100-question qualification exam, About 8 hours of pre-study and 12 hours of post-study will be required. You should plan to pass the exam within the week following class.

Series 26 Limited Principal

The two-day pre-licensure class occurs monthly. Series 26 candidates must commit to 2 weeks of pre-study and 1 week of poststudy. You should plan to pass your exam within 10 days following class.

Series 63 Agents and Advisers

The one-day class occurs each Weekly. No pre-study and 4 to 8 hours post-study is required. You should plan to pass your exam the day following class.

Series 7 Representative

The five-day Fast-Start pre-licensure class occurs monthly. To pass the six-hour, 250-question FINRA exam, Series 7 candidates must commit to 2 to 6 weeks of diligent pre-study and 1 week of post-study. You should plan to pass your exam within 10 days following class.

Series 24 Principal

The two-day class occurs monthly. Series 24 candidates must commit to 2 to 4 weeks of diligent pre-study and 1 week of post-study. You should plan to pass your exam within 10 days following class.

Series 65 and 66 Representatives

This three-day class occurs monthly. Extensive pre-study and post-study is required. You should plan to pass your exam within 10 days following class.
